- A statement about the methods by which your child's progress will be reviewed; and
- A transition plan that includes the speci c goals, actions required, person(s) responsible for actions, and timelines for each educational transition where the student requires support.

The IEP must be completed within 30 school days after your child has been placed in the program, and the principal must ensure that you receive a copy of it. A "placement" for the purposes of creating an IEP means the start of a new grade or new semester, or the placement in a system class such as Learning and Life Skills.

## What is an IPRC?

An Identi cation, Placement and Review Committee (IPRC) is a legal committee of the Kawartha Pine Ridge District School Board. It is mandated under Regulation 181/98 of the Education Act. An IPRC is composed of at least 3 people, one of whom must be the school principal or a supervisory o cer of the Board. Parent/guardian are invited and encouraged to attend the meeting.

# What are the Ministry's Provincial and Demonstration Schools?

The Ministry operates provincial and demonstration schools throughout Ontario for students who are deaf or hard of hearing, who are blind or have low vision, who are deaf-blind, and/or who have severe learning disabilities, as well as those with attention deficit hyperactivity disorder (ADHD). Residential programs are offered at the schools Monday to Friday for students who live too far from school to travel daily.
