## **Bid Irregularities**

Bid irregularities are described herein for purposes of determination of bid compoliatineybid submissions when received for a bid opportunity anedcategorized as follows.

1. Minor Irregularity

A minor irregularity is a deviation from the bid request which affects form rather than substance. The effect on the price, quality, quantity **brede** is not material to the award. If the deviation is permitted or corrected, the bidder would not gain an unfair advantage over competitors. The Board may correct a **inregularity** or permit the bidder to correct a minor irregularity.

2. Major Ir regularity

A major irregularity is a deviation from the bid request that affects the price, quality, quantity or delivery, and is material to the award including required signed documents. If the deviation is permitted, the bidder could gain an unfair advantage over competitors. The Board must reject any bid which contains a major irregularity. The bidder will be notified of the rejection due to the major irregularity.

3. Summary of Irregularities

The following procedure shall govern interpretation of errors identified in mathematical extensions and/or taxes price information:

- 3.1 when a unit price is requested, the unit price quoted shall govern; or
- 3.2 if only a total price is requested, the total price quoted will govern.
